#### Warrant

Kelly reviewed the Square Space Questions submitted. Chat comments reviewed and answered by Kelly.

Zaia shared comments and questions for the record:

- 1. The consultants should plan to utilize the same polling questions for the next set of sessions so that we can discern the variances from the first sessions.
- 2. Question about the display of Option 2, B & C in the March meeting. Not sure it was included

- 3. HRA should be creating a 3-D computer model to visually demonstrate how the property may look with improvements.
- 4. How does the HRA schedule the use of the electronic signs to inform citizens of upcoming meetings?
- 5. How is the HRA dovetailing the draft URP with the DCR Master Plan for the area?
- 6. Request that Chris Diiorio inquire about the total cost for the MBTA bus service in Hull and what the HRA needed to do to obtain a seat at the table on the committee/board that manages the MBTA service for Hull.
- 7. Ask HRA consultants what resources they may have or know, to help the HRA determine the cost of Shuttle Bus Service from the Cohasset and Nantasket Junction commuter train parking lots from Memorial Day to Labor Day?
- 8. HRA should create a chart/matrix/description indicating how an independent developer might modify the HRA property (under various zoning options) versus how the property would be impacted under the HRA draft URP.
- 9. Can Chris DiIorio provide the executive summary of the Housing Production Plan that was approved and submitted to the State?
- 10. The HRA should be getting from the Town Accountant, Tax Collector, and Accounting Administrator the amount of room occupancy taxes collected since July 2019 since Hull is permitted to charge a local room occupancy excise tax of up to 6%, but the money is paid to the state and then the town is reimbursed. HRA should be able to obtain these figures.
- 11. Suggestion that folks driving along Faxton Park in Quincy notice the golf frisbee game structures that might be a fit for the Bayside Park.
- 12. Zaia encourages the HRA to begin a formal dialogue with the Trustees of Reservations to explore a potential partnership and/or purchase of parcels 6, 7,8, 9 as well as parcels 2, 3, 4. The intention will be to include the Select Board in these conversations since all sites that are part of The Trustees of Reservation need parking as well as visitor/educational facilities.
- 13. Zaia encourages the HRA to begin a dialogue with the Hull Select Board to include the re-purposing of Hull Town Hall in the URP based upon retaining Parcel 1 for parking, parcels 2, 3, 5, 6, 7 for potential involvement with the Trustees of Reservation along with parcel 4 or a Visitor Center/Education Center with parking in a low rise building.
